Moving Forward!

- The new State-Mandated sewer Lift-Stations are now installed and operating. These replace stations installed in 1972, and can handle higher flow rates and allow monitoring for issues BEFORE they occur!
- The Village has a new plow & work truck! It was completely funded with interest income, and at no cost to residents!
- The Downtown has been beautified with new Solar street lights. These were funded with an ARPA Grant and installed by a Parma village Eagle Scout and Volunteers!
- Groner Park is now owned by the village! Again, at no cost to residents.



Utility Billing

Due to recent Mail Issues, the Village offers residents the option to receive their utility bill via email. Let the Village office know if you would prefer this option.

Please keep in mind that failure to receive a bill does not waive penalties. Quarterly bills are due 3/15, 6/15, 9/15 & 12/15. Monthly bills are due the 15th of each month.

The Village offers utility bill payment plans. Contact the Village office for details.

The plans are set up with monthly payment the 15th of each month.

Brush pick up

The village does resident branch/brush pick-up as needed. Please make sure that it is piled with the cut ends facing all facing the road. They can not be longer than 5 feet long and 8 inches of diameter. Wet or frozen brush cannot and will not be picked up. Do not include roots, raked debris or building material. (NO METAL!) The village does not pick up brush/branches left by commercial tree services.

Leaf Bags

The Village of Parma Office has approved, compostable, rapidly biodegradable leaf bags for \$4 per 10 bags. When the bags are full (no heavier than 20lbs), tie them off and place them at the curb to be picked up. *Please do not place bags out in the rain.* **Remember, due to combustion hazard, that grass/weeds CANNOT be placed in these bags and will not be picked up by the Village.**

2026 Tax Statements



The 2026 Village of Parma Tax Statements are mailed in mid-July. If you do not receive your statement, please contact the Village Office at 531-4785 . Unpaid Sewer & Garbage bills will be placed on your Village Taxes on May 15th. **Failure to receive a tax statement does not exempt a taxpayer from delinquent penalties and interest.**

Be Mindful of your Neighbors:

- ◆ For the safety and well being of the residents the use of golf carts/go carts on sidewalks and streets within the Village limits is prohibited.
- ◆ Keep our storm drains clear and motorists safe please remember to not put grass/leaves in the streets
- ◆ Due to population density within the Village our zoning ordinance limits most agricultural actives other than gardening.
- ◆ There is No Parking allowed on the Boulevard on Fulton Boulevard. Temporary permits are available at the village office if residents are having an event.

Do you need a permit?

Permits are required for a variety of projects, including pools, electrical, plumbing) fences, decks, roofs, new sheds, construction, driveway changes, and more! Permits are available at the village office. (applications are also on the village website) If the proper permits are not obtained there could be additional fees and fines.



'Flushable Wipes' are NOT septic or sewer safe! **They do not break down**, get tangled in the sewer pumps and do costly damage that can increase utility

Food Assistance

The Village Hope church supplies food boxes to anyone in need on the second Thursday of the month at 11 am. While supplies last. Boxes include fresh produce, and non-perishable food, bread and baked items are sometimes included.



Please be aware that fireworks are prohibited within the Village limits except the day before, the day of and the day after National Holidays ONLY.

Ordinance Reminders:

- The owners of properties within the village are required to maintain, repair, and maintain sidewalks adjacent to or upon their lots and premises in or along the public street and alley rights-of-way in the village.
- ◆ Parking of utility trailers, boat trailers, and campers in the street is prohibited at all times. Commercial vehicles and equipment may not be parked on the streets when not in active use.

Recreational Fires



A permit is required for any recreational fires in the Village. Permits can be obtained at the Fire Department at no cost. The NREPA Public Act 451 prohibits the burning leaves/pine needles/yard waste/storm damage, garbage in the Village or within 1400 ft. of the Village limits.

Granger Trash Service

To ensure the best service from Granger:

Granger will not pick up any garbage that is not in a Granger cart.

- Granger now services the village with an Automatic Side Load truck that provides more safety for the driver. For this truck to work properly, please make sure your cart is within 3 feet of the street and at least 2 feet from poles or any other obstruction. Please place the carts with the wheels and handles away from the street.
- Annual Village Bulk Pick-Up will be June 6th
- Items for Recycling can now be placed in Yellow Granger Bins at the Village DPW building during business hours.
